No single factor responsible
Phase I. Market Gets Over-heated
(January to Mid-September, 1994)
Phase 2. Market decline sets in
(Mid-September 1994 to December 1995)
Phase 3. Weakening of economic confidence
(January-December 1996)
Corporate misgovernance raises public concern
Market ignores good economic fundamentals
